1.1 The meeting was called to order at 9:05am.

2.1 MOTION 1: Motion to approve the agenda as presented. CARRIED

3.0 Introduction / Purpose of Meeting

- 3.1 Motion 5.2.1 was passed regarding the freezing of enrollment of the ARTARx plan.
- 3.2 This motion needs to be revisited now that there has been a decision from the Alberta College of Pharmacy (ACP) regarding our application for a community pharmacy license.
- 3.3 ARTA received a letter on November 24, 2022, saying that the ACP were moving forward with community license.
- 3.4 A pharmacy inspection took place on December 9, 2022, and we passed with flying colors.
- 3.5 On December 12, 2022, we received our community pharmacy license.
- 3.6 ARTA is now working on communications that will start to come out to members in the near future.

4.0 Motions

- 4.1 MOTION 2: Motion to rescind motion 5.2.1 (which reads as follows: That ARTARx plan enrollment be frozen as of January 1, 2023, until a decision is reached on our pharmacy license application, and we can determine appropriate eligibility for enrollment in the ARTARx plan) from the November 23, 2022, Board of Directors meeting. CARRIED
- 4.2 MOTION 3: Motion that ARTARx plan enrollment be suspended as of December 15, 2022, except for members living within the greater Edmonton area, defined to include Edmonton, St. Albert, Morinville, Fort Saskatchewan, Sherwood Park, Camrose, Beaumont, Leduc, Stony Plain, and Spruce Grove. People who have enrolled for ARTARx living outside of these areas will be grandfathered and can continue with current ARTARx coverage. CARRIED
