If you are covered under the ARTA Benefit Plans. this is your friendly reminder to submit your health and dental claims incurred during the 2022 calendar year by December 31, 2023. Any 2022 claims submitted after December 31, 2023, are no longer eligible for coverage.

2023 Premiums & Claims Statements will be available through your MyARTA account no later than February 28, 2024.

They will include all claims submitted before December 31, 2023, so make sure to submit your claims before then if you would like them reflected on your statement for tax purposes.


Each month a committee member will provide our members with helpful information on emotional, spiritual, intellectual, physical, financial, or social wellness.
